

## **Diligent Market Insights Report with S&P Product Terms**

The following additional product terms apply when the Client purchases access to the Diligent Service identified as Market Insights Report with S&P (and any references to "Diligent Service" on this page shall be understood to refer only to such Diligent Service):

1. For the avoidance of doubt, Market Insights Report with S&P is a Reporting, News, and Education Service as defined under the Agreement. Client acknowledges and agrees that data entered into or otherwise submitted through S&P Market Insights shall not be treated as Client Data (or similar terms) as defined under the Agreement. Diligent shall use reasonable measures to secure any such data.
2. All information, data, material and other content provided within the Diligent Service (the "Content") is intended for Client's internal use only.
3. For the purposes of these additional product terms, the term "Market Insight Report" shall mean the S&P Report which appears in the "Activity Center" within the "Issues and Reporting" section on the Diligent One Platform, which provides a summary of financial, market, and peer performance for the Client's business.
4. Notwithstanding Section 14.3 of the General Terms and Conditions, Client's Users may download a pdf of the Market Insight Report to each User's own desktop/computing device, provided that each individual User shall (i) use such downloaded pdfs solely for the Client's internal business purposes; (ii) not upload, copy or transfer to, or store or manage the pdfs in any directory, database or other repository that is shared or can be accessed by others, except for the Client's shared internal business applications and tools for internal document storage, sharing and management (e.g. the download functionality may not be used to populate master security databases); and (iii) not use the Diligent Service as an alternative to obtaining the Diligent Service from and/or pursuant to an agreement with the Content Provider.
5. All other types of external and commercial use, sharing, transmission, publication, or redistribution of the Content by the Client is prohibited and will require Diligent's prior written consent. The Client acknowledges and agrees that Diligent or its third-party Content Providers (as applicable), own all rights, title and interest in the Content, and all proprietary and intellectual rights in and to the Content, including without limitation, copyright and trade secret rights.

acquire, monitor, copy, distribute, display, navigate or search any portion of data forming a part of the Diligent Services; (ii) use the Diligent Services or Content to develop, enhance, train, structure, run or test any Artificial Intelligence; or in conjunction with trained Artificial Intelligence, in each case whether such Artificial Intelligence is solely data driven, involves human intervention, or both.

8. Access to the Content is subject to termination in the event that any agreement between Diligent and the Content Provider terminates for any reason.
